DECISIONS

I authorized dispensation to be issued for Gadsden Council No. 56 to hold elections and install officers out of statutory time. At two Festival Classes conducted at the Birmingham Metro York Rite Temple, one class on May 17th and one on October 17th and 18th, where there were several Councils represented, I issued dispensation for all to vote out of time, conduct business and confer degrees. At a one day Festival Class conducted at Ft. Payne on January 24th, 2010 I issued dispensation for those Councils represented to vote out of time, conduct business and confer degrees. I made the decision to present the Ft. Payne Council UD with a Charter for their continued operation as a member of the Grand Council of Royal and Select Masters of the Grand York Rite Bodies of Alabama. The Ft. Payne Council will be presented with their Charter during the Annual Assembly at Birmingham this year.

AUDIT

Grand Secretary-Recorder Hiram Williams was given authority to make the accounting books and records available for the Audit Committee to complete its work. Companion James C. McGee, as Chairman of the Audit Committee, supervised the audit and has reported the findings to the Grand Council. The finding will be released during our Assembly here.

Note 1 - Summary of Significant Accounting Policies

A. Basis of Accounting

The Grand Council's policy is to prepare its financial statements on the cash basis of accounting. Under this method certain revenue and the related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements do not purport to present the current financial position.

B. Inventories

Inventories are carried at the lower of cost determined by the first-in, first-out method, of market.

C. Property and Equipment

Property and equipment are recorded at cost and were depreciated over the estimated useful lives of the related assets. Depreciation was computed on the straight-line method for financial reporting purposes.

Note 2 - Tax Status

The Grand Council is exempt from federal income tax under Internal Revenue Code Section 501©, and from state income tax under Alabama Code Section 40-18-32. An information return is filed each year on IRS form 990.

Note 3 - Restricted Assets

A Triennial Reserve account is established as a reserve to cover expenses for specific officers to attend the Triennial Meeting. During the year there was an increase in the balance of this reserve account to \$ 1,300.00

On November 17th, 1999, the Brethren of this great state elevated Bro. Crawford to the highest office in Masonry, that of Grand Master of Masons. He served that office and the Brethren of this state throughout the year with humility and distinction, culminating with him presiding over the One Hundred and Eightieth Annual Communication of this Grand Lodge on November 21st and 22nd, 2000.

MW Bro. Crawford continued to serve the craft in numerous ways. He served as Most Excellent Grand High Priest of the Grand Chapter of Royal Arch Masons of Alabama, Right Eminent Grand Commander of the Grand Commandery of Alabama and was serving as Grand Principal Conductor of the Work of the Grand Council of Royal and Select Master of Alabama at his death. He was a member of Alabama Prior #31, Knights of the York Grand Cross of Honor, St. Dunstan Conclave of the Red Cross of Constantine, Emerst W. Johns Sovereign York Rite College, Council of Anointed High Priest, Order of the Silver Trowel, Knight Crusaders of the Cross and Jerusalem Tabernacle Holy Royal Arch Knights Templar Priest.

He was active in the Scottish Rite Masonry in the Valley of Birmingham and on October 30th, 1999 he was invested with the honor of Knight Commander of the Court of Honor. At the time of his death he was serving on the Divan of Zamora Temple as Assistant Rabban.

As a young lecturer and later as a Grand Lodge Officer I sought Bro. Bobby's advice and wise counsel on matters of Masonry. I can truly say that "I am a better man and Mason for having known Bobby Crawford".

The day Jim passed away was indeed a sad day for all of us who knew him. We knew we had lost a fine person and true Mason.

Jim hopefully meant something to many of you. Personally, he was to me a Masonic mentor. He was also a person I could truly confide in. I could talk to him about anything because he never judged or reproved me. He always had some sound advice ready for me as I progressed in Masonry.

Jim was a Mason who excelled. He was a member of every honorary body in Alabama appended to the York Rite of Freemasonry as well as a 33rd degree Scottish Rite Mason. He led this Grand Council with distinction as Grand Illustrious Master from February, 1996 to February, 1997. He was a man to be both admired and imitated.

Jim gave the impression that he was somewhat dour in outlook. True, he knew how to be serious at times, but he also knew when to apply his dry humor and wit to a situation. As a friend he was also very loyal and kind. He always enjoyed being with his Masonic brethren. He was also very polite; he was the kind of man who always opened doors for ladies. Sadly, his spouse and the love of his life, Jackie, predeceased him in 1997, which had a devastating effect on him that remained for the rest of his life.

I know Jim, Masonically speaking, left many things undone and others that he never had a chance to start. 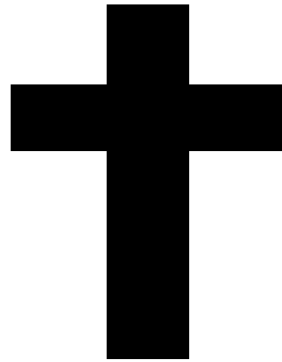

Proposition to Amend the By-Laws of the Grand Council of Royal and Select Masters of Alabama.

WHEREAS, Article X, Section 18 of the By-Laws now allows for membership in only one Council within this jurisdiction, and WHEREAS, there are members within this jurisdiction that desire to hold dual membership in other subordinate Councils within this jurisdiction and in the interest of allowing individuals to contribute more to the good our subordinate Councils, Therefore BE IT RESOLVED, That article X, Section 18 be deleted in its entirety and replaced with the following:

DUAL MEMBERSHIP:

Section 18: A Companion can be a member of two Councils in this Grand jurisdiction, provided both Councils record him as a dual member, and his membership is reported to the Grand Council. However, a dual member cannot hold elected office in both Councils at the same time. Any matter that affects membership in either Council will likewise affect membership in both Councils. Furthermore, it is permissible for a Companion in this Jurisdiction to hold membership in another Grand Jurisdiction, provided said other Grand Jurisdiction is in fraternal relations with this Grand Jurisdiction, and further provided that said other Grand Jurisdiction legalizes dual membership. Likewise, a Companion of another Grand Jurisdiction that qualifies as above who properly applies and is duly elected can become a dual member of a subordinate Council in this Grand Jurisdiction with all rights and obligations of regular membership.

Should a Companion holding dual membership within Alabama desire to withdraw his membership from one Council, he shall notify the Council from which he desires to withdraw his membership of his decision in writing, and if he has paid current dues and no charges are pending against him, the Secretary of the Council will carry him as withdrawn and notify the other Council in which dual membership was held of the date that the member is no longer a dual member. A Companion holding membership in Alabama and another Grand Jurisdiction may continue as long as the Companion remains in good standing in his basic (Home) Council; however, any matter affecting the basic membership will also affect the dual membership.

X...On October 1st William C. Havens Renounced Masonry. MacArthur Davis, Deputy Grand Master assumed the duties as Acting Grand Master and Presided over the Annual Assembly on February 23, 2003

Y...On December 31st, 2005 Companion Fred W. McCluskey, Jr. and Companion Arthur C. Harding resigned and Companion Robert C. Grigsby, Jr. was appointed as Grand Treasurer and Companion Hiram O. Williams, Jr. was appointed Grand Recorder.

Z...At the Annual Assembly in February, 2006 Companion Arthur C. Harding was elected as Grand Recorder Emeritus and Most Illustrious Past Grand Master (honorary). Most Illustrious Companion Fred W. McCluskey, Jr. was elected as Grand Treasurer Emeritus. Companion Joe D. Lee was elected Grand Treasurer and Companion Hiram O. Williams, Jr. was elected Grand Recorder.
