But although we are doing a good job in attracting new members, we need to work equally hard to retain the ones we already have. These men have lost interest for some reason. We need to make the effort to find out why and how they lost the desire to Council Masons. We need to reenergize the members who are not active members in our local Councils. Perhaps a refresher session concerning the Council degrees for those who might have forgotten some of the important lessons of the Council of Royal and Select Masters. Having a short education topic presented is another idea to attract members and make them want to come to our meetings.


# Grand Council Necrology, February 2020

He left the position of Illustrious Grand Steward open until our next annual Communication in February 2019, when 2 positions were needed to be elected, Illustrious Grand Conductor of the Work and the Illustrious Grand Steward.
