STATE OF THE ORDER

We, your Membership Committee, are pleased to submit the following report:

We started this year with 996 active members in our Grand Commandery. We knighted sixty-eight new Sir Knights in 2022. This tells me that

our Sir Knights are actively trying to introduce York Rite Masonry into the membership of our Blue Lodge brethren, and are doing a good job of sparking their interest of our organization.

However, we did have thirteen demits and forty-one to go suspended for non-payment of dues. These numbers are troubling we think of what are the reasons for the losses of our numbers. There is no sure fire answer to these questions unless we ask those who went suspended, as to why they chose not be among us. I feel this is something that needs to be addressed. The next time we hear of a Sir Knight going suspended maybe we should go out of our why to ask that question, why.

Unfortunately, we did loose thirty eight members to death this year. And there is nothing that can be done about this; other than to realize that the average age of our organization is high and we really need to try to recruit any of our younger blue lodge brethren which would help to bring down that overall average age.

We did see eleven Sir Knights get reinstated this past year, as well as, six who affiliated with us. This put us with an ending total of 989 members at the end of the year with a net change of minus seven members, or a .7% loss. This is still good news compared to some of the membership loss averages of other organizations.

In conclusion, I believe that with the help of the Sir Knights of this Grand Commandery, we can turn this loss of .7% into a gain. We would like to thank our Right Eminent Grand Commander, Sir Knight Ronald Andress for allowing us to serve him this past year and thank him for his continued support.



2023 Legislative Call Call Item # 1

Proposed by: SK Brian McDonald, Captain General, Mobile Commandery #2

Purpose: to allow the use of the Templar Apron Amend: The Uniform Code of the Grand Commandery

TEMPLAR APRON

Whereas, Chapter XXII Section 261 of the Grand Encampment Constitution was amended at the 68th Triennial Convention that a Grand Commandery may provide for the wearing of a Templar Apron in its Uniform Regulations. A Grand Commandery may specify with which of its authorized uniforms a Templar Apron may be worn.

Therefore, be it resolved the Grand Commandery of Alabama Statutes be amended by adding a new Chapter, consisting of one new section, as follows:

Aprons

(To be inserted in a separate section before **OPTIONAL TEMPLAR UNIFORM**)

It is permissible for Grand Commandery Officers and members of Constituent Commanderies to wear an apron with Templar Uniforms as described in Sections 250 (Dress Uniform), 250a (Cap & Mantle), 251 (Fatigue Uniform), 259 (Summer Uniform) as follows:

A. Traditional Apron. A Traditional Apron shall conform substantially in design to the images below. It shall be trimmed in gold for Sir Knights of the Rank of Commander or Past Commander and Above, and in silver for Sir Knights below the rank of Commander. A Traditional Templar Apron may only be worn in an Asylum where only Knights Templar are present



B. Contemporary Apron. A Contemporary Apron shall conform substantially in design to the image below. It shall be trimmed in Gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Contemporary Apron may be worn in both private and public settings. It is permissible to manufacture an apron so that it is reversible with the Traditional Apron on one side and the Contemporary Apron on the other.



C. If a Sir Knight appears in uniform in a tiled Masonic Lodge, he shall NOT wear such apron as is in accord with the Grand Lodge of Alabama F&AM.

First Annual Conclave was held in Montgomery, Alabama on Friday November 30, 1860

Grand Commandery office moved from Montgomery to Birmingham after election of Thomas W. Oliver as Grand Recorder in 1962

(A)At the Annual Conclave, April 1963, Earl D. Holmes was elected and installed as Grand Commander, but he died before he could serve.

(B)At the Annual Conclave, April 1973 Thomas W. Mann was elected Grand Recorder. Thomas W. Oliver was elected Grand Recorder Emeritus, and the Annual Conclave Date was changed from April each year to the last Monday in February to correspond with Grand Chapter and Grand Council.

(C)As proof of continual effort of Alabama to promote York Rite unity, the first combined meeting of The Grand Chapter, Grand Council and Grand Commandery was held in February 1974. On November 1, 1974 the Grand York Rite office was moved to 3621 South Fifth Avenue Birmingham.

In September 1979 the Grand York Rite office was moved to 5504 ½ North First Avenue Birmingham 35212.

On May 16, 1980, James A. Kile was appointed Grand Treasurer to succeed Hoyt McClendon who resigned.

At the Annual Conclave February 1981. Hoyt McClendon was elected Grand Treasurer Emeritus.

(D)On September 1, 1991 Thomas W. Mann and James A. Kile resigned as Grand Recorder and Grand Treasurer. Arthur C. Harding was appointed as Grand Recorder and Fred W. McCluskey, Jr., was appointed Grand Treasurer.

At the Annual Conclave February 1992, Arthur C. Harding was elected Grand Recorder and Fred W. McCluskey, Jr., was elected Grand Treasurer. Thomas W. Mann was elected as Grand Recorder Emeritus and James A. Kile was elected Grand Treasurer Emeritus.

(E)On June 23 1997, Past Grand Commander Robert L. Byars, Jr., renounced York Rite Masonry and is no longer a member.

On January 13, 1999 the Grand York Rite office moved to 3430 Ratliff Road, Irondale, AL 3510

(F)On December 31, 2005, Arthur C. Harding and Fred W. McCluskey, Jr., resigned as Grand Recorder and Grand Treasurer, Hiram O. Williams, Jr. was appointed Grand Recorder and Robert C. Grigsby, Jr. was appointed Grand Treasurer.

At the Annual Conclave February 2006, Arthur C. Harding was elected Grand Recorder Emeritus and Fred W. McCluskey, Jr., was elected Grand Treasurer Emeritus. Joe D. Lee was elected Grand Treasurer and Hiram O. Williams, Jr., was elected Grand Recorder. Also Fred W. McCluskey, Jr., was elected Grand Commander Honorary.

February 24th, 2012 was the beginning of our Annual Meetings being held on the last Friday of February each year. This was presented in February 2010 and laid over until February 2011 on which the vote was taken and passed to meet on the last Friday of February each year.

(G)October 1st, 2013, Sir Knight Arthur Lee Campbell, III Eminent Grand Warder Resigned from Masonry with no reason stated.

(H)On May 25, 2020 Ed Mason resigned as Grand Treasurer. Thomas H. Nesbit was appointed Grand Treasurer. On October 1, 2020 Hiram O. Williams resigned as Grand Recorder. James C. McGee was appointed as Grand Recorder. At the Annual Conclave February 2021 James C. McGee was elected Grand Recorder and Thomas H. Nesbit was elected Grand Treasurer. Hiram O. Williams was elected as Grand Recorder Emeritus and Ed Mason was elected Grand Treasurer Emeritus.

(I)On January 15, 2021 Eminent Grand Generalissimo Thomas Lott resigned his position in the advancing line.

CHRONOLOGY

Titles of Meetings and Dates of Bodies Composed Exclusively of Masons.

The ordinary calendar, or vulgar era, is not generally used by Freemasons in dating their official documents. They have one peculiar to themselves, differing according to their various Rites.

ANCIENT CRAFT MASONS in all parts of the world, add 4,000 years to the Christian era, calling it *Anno Lucis*-Year of Light; abbreviated A.L. (This fact has a symbolic reference, not because they believe Freemasonry is, but that the principles and light of the institution are coeval with the creation. (*See below*.) F&AM Lodges hold "Communications."

<u>ROYAL ARCH MASONS</u> date from the building of the second Temple-530 B.C. Their style is, therefore, *Anno Inventionis*-A. Inv. - in the year of the discovery. Royal Arch Chapters hold "Convocations."

<u>ROYAL AND SELECT MASONS</u> date from the completion of Solomon's Temple 1000 B.C. Their style is *Anno Depositionis*-A. Dep.-in the year of Deposit. Royal and Select Councils hold "Assemblies."

<u>KNIGHTS TEMPLAR</u> date from the organization of the Order in 1118 A.D. Their style is, therefore, *Anno Ordinis*-A.O.-in the year of the Order. Knight Templar Commanderies hold "Conclaves."

<u>ORDER OF THE HIGH PRIESTHOOD</u> dates from the blessing of Abraham by the High Priest Melchizedek, which occurred 1914 B.C. Their style is *Anno Benedistionis*-A.B.-in the year of the Blessing. Councils of Anointed High Priest hold "Convocations."

<u>ANCIENT AND ACCEPTED SCOTTISH RITE MASONS</u> use the Jewish Calendar, which adds 3760 to the Christian era, styled *Anno Mundi-*A.M.-year of the World. Or, they sometimes use the Hebrew year which begins on the seventeenth of September or feast of Tisri, using the initials A.H.-*Anno Hebraico*.

<u>TEMPLES, A.A.O.N. MYSTIC SHRINE</u>; Each thirty years from the Hejira, or July 15th, A.D. 602 constitutes a cycle. Nineteen of these years contain 355 days, Eleven, 356.

RULES FOR MASONIC DATES

ANCIENT CRAFT MASONS - Add 4,000 years.

Thus: 2020 + 4,000 = A.L. 6020

ROYAL ARCH MASONS - Add 530 years. Thus: 2020 + 530 = A. Inv. 2550

ROYAL AND SELECT MASTERS - Add 1,000 years. Thus: 2020 +1,000 years = A. Dep. 3020

KNIGHTS TEMPLAR - Subtract 1,118 years.

Thus: 2020 - 1,118 = A.O. 902

 $\frac{\text{ORDER OF HIGH PRIESTHOOD}}{\text{Thus: } 2020 + 1,913 = \text{A.B. } 3,933}$

SCOTTISH RITE MASONS - Add 3,760 years.

Thus: 2020 + 3,760 = A.M. 5780
