#### REPORT OF MEMBERSHIP COMMITTEE

To the Most Illustrious Grand Master and Companions of the Grand Council of Royal and Select Masters of Alabama.

It is the responsibility of this committee to report the membership status of the subordinate councils. This past year has been a year of continuing the rebuilding from the effects of the COVID problems. We are beginning to see the light at the end of the tunnel on our journey back to normalcy.

However this year we continued to lose members. This year our loss in membership is almost double of what it was in 2021. We lost 21 members this past year. Although this seems at first glance to be a small number, it does represent a drop of slightly over 2% of our total membership. We are fast approaching the point where even the loss of one member is significant. Out of 11 Subordinate Councils, 3 had a positive gain, 3 had zero growth, and 5 lost members.

We lose members in 3 categories; Demits, Suspensions, and Death. We cannot do anything about death. Demits occur for a variety of reasons and if a member requests it and is in good standing, the demit is issued. But the area where we can most affect membership is by working to improve our suspension numbers. We have already invested time and effort into these men. We need to determine why they lost interest. This year we lost 48 men to suspension. If we could have cut that number in half, we would have had positive growth.

Our goal for our subordinate Councils next year should be to make a concerted effort to retain all of our current members and make attempts to bring back former members.

## REPORT OF THE COMMITTEE ON CRYPTIC MASONS MEDICAL RESEARCH FOUNDATION

To the Most Illustrious Grand Master of the Grand Council of Royal and Select Masters of Alabama:

"We make a living by what we get. We make a life by what we give."

Winston Churchill

During the past year the Alabama CMMRF Committee has made great strides at forwarding the CMMRF message and has gained national and international notoriety for its efforts. Before going into specifics, it is good to take a few moments to understand what the CMMRF program brings to York Rite Masonry as well as people suffering with chronic illnesses in our community, state and country.

Consider; if you will, the family members, friends and perhaps even yourself, who have been afflicted with such illnesses as peripheral arterial disease (PAD), or diabetes, or arthritis, or Abdominal Aortic Aneurysm (AAA) for which there is a 75% mortality rate, or heart failure, or stroke, or pancreatitis or even heart attacks and stroke (the leading cause of death in America). Consider for a moment the lives of those individuals after having been struck down by one of those afflictions. How have their lives changed and been degraded; and what levels of pain do they manage on a daily basis? Have they lost much of their lives to simply dealing with conditions that have robbed them of their special talents, skills and abilities to perform everyday tasks, or work in their chosen vocation?

Now consider if there was relief in sight for those who have been struck down by one of those afflictions. What if we could stop the amputations associated to PAD and control the pain by restoring blood vessels? What if we had a means of stimulating the pancreas to produce its own insulin, thus eliminating the need for testing and insulin injections in Type 1 diabetics? What if there was a means of testing for abdominal aortic aneurysms as well as a means of reducing the inflamed cells that lead to a rupture of the aorta? What if we could replace sections of the heart that have been damaged and destroyed by heart attacks? What if damaged brain cells could be repaired after suffering from a stroke? These and many other research projects are going on today with some having near term solutions at hand for some of our most common and devastating afflictions.

The Cryptic Masons Medical Research Foundation (CMMRF) is the premier organization that is taking on these challenges and other research projects, as well as finding the solutions to afflictions that have plagued mankind for as long as history will record.

CMMRF was incorporated on March 6, 1986. The driving force behind this new corporation was interest shown by Most Puissant General Grand Master Ben Mandlebaum, of the General Grand Council, Cryptic Masons International. MPGGM Mandelbaum and two other individuals found the need to develop a foundation that could provide direct support to the Indiana University School of Medicine based upon the critical research that they were performing into areas of medical science that commonly afflict the majority of Americans in everyday life. These men then created that foundation to serve as an outreach project that could be supported by cryptic masons everywhere. Currently, the research team is headed up by Dr. Michael Murphy who has made tremendous strides in eight separate areas of research. For a moment, let us examine some of the fields of research that are being looked at with significant results having been achieved.

- 1. Abdominal Aortic Aneurysm (AAA) This is an enlarging of the aorta that subsequentially leads to death through a rupture that could occur at any time, without warning. There are no tests for detection of this condition, until now. This condition has been found to leave a specific protein that can now be detected. Warning those afflicted with it, so that they can receive treatment prior to rupture is a life saving accomplishment. Further, treatments for inflammation are being developed that can reduce the risk of AAA and subsequent heart attacks.
- 2. Peripheral Arterial Disease (PAD) This disease afflicts millions of people and is responsible for 53,000 amputations per year. Those who have it live in chronic and disabling pain. Currently, a system is being worked on that allows adult stem cells to be introduced into the afflicted areas of the legs, which generates new blood vessels and eliminates the pain and tissue atrophy.
- 3. Heart failure Everyone knows what heart failure is and the consequences of it. Right now the Indiana University School of Medicine is working on a means introducing healthy adult stem cells into the afflicted and damaged portions of the heart in an effort to repair those areas, and restore circulation. This is currently in Phase II trials and headed quickly to Phase III trials, which will incorporate a large population of those with heart disease into their trials.

4. Diabetes – Diabetes essentially is a condition where the pancreas can no longer produce the insulin that the body requires, thus sugars and carbohydrates can not be broken down leading to elevated levels of glucose. Through the use of adult stem cells from volunteers, research is on going that will allow the pancreas to be stimulated into producing its own insulin. Think about what that means to a child or adult suffering with Type 1 diabetes.

Four other similar projects are underway researching cancer, stroke, arthritis and pancreatitis. Each project has had similar success and is on its way towards bringing relief to patients that have been afflicted by these diseases and now rendered disabled or dead prematurely.

Consider; if you will, how our families' lives, our friends' lives and even our lives will be affected when these critical areas of research come to fruition. Consider all of these people and what parts of their lives will be restored. And, consider how disability can be turned around into ability. Ability to live pain free, ability to not be dependent on testing and injections of insulin, ability to walk once again and spend time with family and friends. Consider all of this and more; and giving millions of people with no future, other then a future of suffering; life as it should be. Consider!!!

This past year, we have brought in a total of \$7,709.00 into the foundation, with a good start on 2023. Our goal for 2023 is to bring in \$10,000.00 or more into the program. We will be relying on various fund raisers throughout the year, as well, as the donations and contributions made by individuals and companies that wish to support this program. We understand that this past year has been one of financial hardships, excessive inflation and this year will herald in a recession. Money is tight everywhere and getting tighter. The Amazon Smiles program, that brought in several hundred dollars for Alabama throughout the year has been discontinued, which will add an additional burden upon the committee. However, we have come up with guidance documents and a one year operating plan to meet the new challenges that will be seen this year.

To date, we have instituted an Educational program, developed fact sheets, as well as business plans to address all contingences. We are working toward having a CMMRF annual dinner, as well as other fund raising projects. We are also working towards a life membership program for CMMRF, which would also have a return for the individual councils. Robert Levin has been working on a formalization of such a program.

On the national and international fronts, our fact sheet has been adopted by CMMRF as the standard document to explain the ongoing research projects. This fact sheet has been distributed throughout the nation as well as the world and is now posted on the official CMMRF web site. Further, a CMMRF National Business Plan has been developed and submitted as an operational document to pave a future direction for the CMMRF program. Modeled after the one year plan, this document allows for numerous ideas to be explored and possible implementation of new programs.

One such adoption from the plan is that the month of March will now be adopted as CMMRF month, with the goal of having every York Rite Council throughout the country make a donation of \$100.00 to go directly into the research projects. Another adoption is to have each Thrice Illustrious Grand Master make a written proclamation of support for the CMMRF program and dedicated CMMRF month.

One key change that has been made is that we have added a medical advisor to our committee. Companion Dr. Robert Garner has graciously offered his time and medical advice to review the achievements being made by the University Of Indiana School Of Medicine and provide advice on the medical side of the equation. Dr. Garner's counsel has been greatly appreciated.

In conclusion, I would like to share a quote from Mother Teresa.

"We know only too well that what we are doing is nothing more than a drop in the ocean. But if the drop were not there, the ocean would be missing something"

As York Rite Masons, we are defined by our charity and outreach to our communities. This is our purpose and it is our mission. We make the world a better place based upon the programs we elect to support, as well as our charitable spirit. It is great that we have our fellowship and support for the craft. Our ritual provides identity to us, but our outreach is what truly defines us. Solutions are at hand with the support of all Cryptic Masons.

By each of us contributing our individual drops, we are in the midst of creating an ocean that will bring new hope to those suffering from the diseases that the CMMRF research team is seeking solutions for. Blessings to all!!!

AA...On February 28th, 2013 Illustrious Grand Principal Conductor of the Work Companion Jack A. Elliott Died. Most Illustrious George L. Marshall, Jr. according to the Grand Council of Royal and Select Masters of Alabama Constitution moved all elected officers up one position in line except the Deputy Grand Master, Treasurer and Recorder. He appointed Companion Raymond C. Dunn as Sentinel. This was done at a meeting of the Grand Council of Royal and Select Masters of Alabama March 9th, 2013 at Birmingham Metro York Rite Temple 3430 Ratliff Road, Birmingham, AL with an effective date of April 1st, 2013. See the minutes attached to these proceeding.

BB...June 2018 Illustrious Grand Principal Conductor of the Work Companion Joshua Barney Lusk Died. Most Illustrious Ronald G. Andress according to the Grand Council Royal and Select Masters of Alabama Constitution moved all elected officers up one position in the line except the Deputy Grand Master, Treasurer and Recorder. He left the position of Illustrious Grand Steward open until our next annual Communication in February 2019, when 2 positions were needed to be elected, Illustrious Grand Conductor of the Work and the Illustrious Grand Steward. CC...Right Excellent Grand Treasurer Edward L. Mason gave up the Treasurer place due to health and on 05/23/2020 Thomas H Nesbit was appointed Grand Treasurer by MIGM Cooley. Right Excellent Grand Secretary Hiram O. Williams, Jr. gave up the Secretary's place after 15 years of service and on October 1st, 2020 MIGM Cooley appointed James C. McGee as the new Grand Secretary. These appointees will be voted on in the 2021 194th Annual Communication in February at Birmingham, AL.

#### **CHRONOLOGY**

#### Titles of Meetings and Dates of Bodies Composed Exclusively of Masons

The ordinary calendar, or vulgar era, is not generally used by Freemasons in dating their official documents. They have one peculiar to themselves, differing according to their various Rites.

ANCIENT CRAFT MASONS: in all parts of the world, add 4,000 years to the Christian era, calling it Anno Lucis-Year of Light: abbreviated A.L. (this fact has a symbolic reference, not because they believe Freemasonry is, but that the principles and light of the institution are coeval with the creation. (see below) F&AM Lodges hold "Communications."

Royal Arch Masons: date from the building of the second Temple-530 B.C. Their style is, therefore, Anno Inventionis-A. Inv. – in the year of discovery. Royal Arch Mason Chapters hold "Convocations."

Royal and Select Masters: date from the completion of Solomon's Temple 1000 B.C. Their style is Anno Depositionis-A. Dep.-in the year of Deposit. Royal and Select Councils hold "Assemblies." Knights Templar: date from the organization of the Order in 1118 A.D. Their style is, therefore, Anno Ordinis-A.O.-in the year of the Order. Knights Templar Commanderies hold "Conclaves." Order of the High Priesthood: dates from the blessing of Abraham by the High Priest Melchizedek, which occurred 1914 B.C. Their style is Anno Benedistionis-A.B.-in the year of Blessing. Councils of Anointed High Priest hold "Convocations."

<u>Ancient and Accepted Scottish Rite Masons:</u> use the Jewish Calendar, which adds 3760 to the Christian era, style Anno Mundi-A.M.-year of the World. Or they sometimes use the Hebrew Year which begins on the seventeenth of September or feast of Tisri. Using the initials A.H.-Anno Hebraico.

<u>Temples, A.A.O.N. Mystic Shrine</u>: Each thirty years from the Hejira, or July 15<sup>th</sup>, A. D. 602 constitutes a cycle. Nineteen of these years contain 355 days, Eleven,356

#### **RULES FOR MASONIC DATES**

ANCIENT CRAFT MASONS: Add 4,000 Years Thus:2019 + 4,000 = A.L. 6019

ROYAL ARCH MASONS: Add 530 Years. Thus: 2019 + 530= A. Inv. 2549

ROYAL AND SELECT MASTERS: Add 1,000 Years Thus: 2019+1000= A. Dep. 3019

KNIGHTS TEMPLAR: Subtract 1,118 Years Thus: 2019-1118= A.O.901

ORDER OF HIGH PRIESTHOOD: Add 1,913 Years Thus:2019+1913= A.B. 3932

SCOTTISH RITE MASONS: Add 3,760 Years Thus: 2019+3760= A. M. 5779
